This is a Christmas tree identified by a local gardner which is currently leaning towards my house 51 Station Road and if it is to fall would hit part of my neighbours house, 53 Station Road. It would also damage the current fencing we have up to separate the gardens. It is around 25

to 30 meters in height and around 10 meters distance from both mine and next doors house.

The work will be carried out once approved by our local gardener. We would like to cut down this tree to the bottom of the trunk leaving in the roots as they are too large for removal. We would also like to replace this christmas tree with a smaller fruit tree such as plum further down the garden which will not only benefit us but wildlife in our surrounding area.
