- 1. London Plane front of block 25 - Crown Thin. Removing selected up right epicormic growth which is rubbing or have potential to rub on main branch structure and remove major deadwood greater than 20mm in diameter. Remove old nest from upper crown 20x20m tree. Works to prevent limb failure

- 3. Lime between blocks 25 - 31 - Re-Pollard back to previous pollard points, removing approximately 2.5 metres. Ganoderma fruiting body evident at base 14x9m down to 11.5x6m safety works

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
