TPO 014 Tree Ref: G2 (Our ref: T19 Horse Chestnut) Report findings: Basal view limited due to epicormics, bifurcating stem at 2 meter, multiple cavities requiring aerial inspection as well as multiple unions. Deadwood present. Epicormics in tree obscuring views. Scope of work: Crown clean and thin.

TPO 014 Tree Ref: G5 (Our Ref: T16 Atlantic Cedar) Report findings: Deadwood present, signs consistent with historic failure, heavy overextending limbs, previous collar cuts showing good compartmentalisation. Scope of work: Removal all deadwood greater than 25mm, reduce in weight overextending heavy limbs to reduce chance of failure, also to reduce wind sale. Reduce up to 3 meters on overextending lateral pendulous growth up into suitable growth.

TPO 014 Tree Ref: G3 (Our ref: G1 Large-leaved Lime Report findings: Basal inspection view obscured by epicormic growth. Lapsed pollards at 7 meters. Deadwood in canopies. 3rd tree in from T5 with swept stem, corrects at 4 meters, canopy asymmetrical on east side. Secondary most previous pruning: Scope of work: Removal epicormic growth to crown break and inspect bases.

TPO 014 Tree Ref: G3 (T8 Large-Leaved Lime): Report findings: Basal view restricted, large fair condition foliage, fair symmetry in crown. Lower west side of crown supressed by leylandii below. Scope of work: Crown raise to 3 meters, remove any deadwood, inspect base and unions from an aerial viewpoint, crown clean.
