T11- Elm

Condition - Dead - Percussion test indicate basal decay

Proposal - Fell

T12- Weeping ash

Condition - Dead/dying - Percussion test indicate significant basal decay, large quantity of epicormic growth at base. multiple previous limb failures

Proposal - Fell

T19 - Horse chestnut

Condition/description - Good, mature tree in good health. Open balanced spreading crown. Multi-stemmed at 4 m. Large hazardous overextended beam limb with helical wounds in lower north side crown.

Proposal - Reduce overextended limb by 5 m to prevent major failure.

T22- sycamore

Condition - Large stem wound on north east side from base to 2.5m - 45% of circumference - exposing heartwood. Percussion test indicate significant decay at base.

Proposal - Fell

T26- sycamore

Condition - Large stem wound on north west side from base to 1.25 m - exposing heartwood - 25% circumference. 3x Limb loss wounds below 5 m. 1x significant exudation/bacterial wet wood. Large amounts of degraded fruital body's at base stem wound. Moderate deadwood throughout crown.

Percussion test indicate significant basal decay and stem decay.

Proposal - Fell

T31- common ash -

Condition - Dying - Ash die back visibly present. Terminal decline. Large deadwood throughout crown overhanging footpath/road.

Proposal - fell

T33 - sycamore

condition - good but presence of large deadwood in upper centre of crown

Proposal - Removal of deadwood.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

### Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
