T5 - Swedish Whitebeam, colonised by wood borer beetle, decay in scar at base, half of mainstem has snapped. Fell tree due to condition.

- T14 Sycamore, major crown die back. Fell tree due to condition.
- T38 Norway Maple, Dead. Fell Tree due to condition.

Fell Tree away from other existing trees. It is not felt that replanting is necessary due to the high density of trees in the area. Replanting would lead to overcrowding.
