Our first draft was looked at and the project was deemed to be too wide and perhaps too high in relation to the existing house. We therefore reduced the width of the build and the size of the fenestration to the front and set it back a bit more as suggested. The roof was redesigned to be part pitch and flat so as to have less impact.
