The work is proposed to improve clearance of sycamore tree reference T1 to the property and to 12 Ridgmont Close.

Crown raise up to 7 metres to include removal of lowest 2 lateral branshes. Lowest remaining limb to reduce by 1.5 meters (15%).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
