Tree 1 & 6 Sycamore Cut 5% all way round, make safe, reshape and tidy. Trees 2,3,4,5 Oak Cut 10-15% all way round, make safe, remove dead/dangerous limbs, reshape. Tree 7 Silver Birch Cut to gutter level of house. Cut 50% of top to allow more light. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
