The front of the property features a grassed lawn and shrubbery to the front boundary behind a low brick wall. A concrete driveway is present within the site's front garden, providing off-street vehicle parking. There is a garage to the side of the dwelling. The property benefits from a substantial rear garden (the largest garden in this group of houses, Danecourt Road, Church Road and Chapel Road).
