Statement of work:

T1 Leyland Cypress - Dead tree on the rear LHB: To carefully section fell as close to ground level as possible.

Reason: Dead tree.

H1 Griselinia - LHB: Crown Reduction - To reduce the overall height by up to 1 metre and shape accordingly. To include cutting back from the edge of the garage to the edge of the gutter to maintain privacy.

Reason: General Maintenace.

H2 Mixed hedge - Mixed hedge comprising of Cypress and Hawthorn running across the rear boundary: Hedge reduction - To reduce the overall height by up to 2 metres and trim the face of the hedge into a tight compact face.

Reason: General Maintenace.

T2 Maple - Rear RHB: Crown Reduction - To reduce the height and radial spread of the canopy by up to 1.5 metres, maintaining a natural shape and remove major deadwood. To include lifting the lower canopy by up to 3 metres and sever lvy at the base.

Reason: General Maintenace.

T3 Cotoneaster - Rear RHB: Crown Reduction - To reduce the overall height by up to 3 meters and shape accordingly.

Reason: General Maintenace.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
