Thank you for your email,

I have been advised by the tree surgeon there will not be any pruning of the sycamore , holly or yew only removal of dead wood above 2m . Only the holly will have some branches removed below 2m and these are from regrowth from the base of the tree, and between 2m and 4m three branches need to be taken back towards the trunk as they are growing into and shading a cherry tree and other shrubs but only by 1.5 / 2m , so keeping the shape of the holly tree. The maximum size of the branches involved is 10 cm diameter.

Good afternoon,

In reply to your email this morning, the removal of the dead wood from the Sycamore will not lead to any reduction in crown height just a shaping and tidy up, however the Holly crown height will need to be reduced no more than 2 m and shaped as it is overpowering the Yew that is next to it, the Holly tree is approximately 15m tall. The Yew will not need to be reduced in crown height just shaped and tidied up.

Good morning,

I am currently validating the above tree application. With regards to the Sycamore and Holly, permission is not required for the removal of dead wood. However if you are then reducing the crown further to shape the trees we will require measurements for works in metres. For example, overall crown reduction by up to 2 metres.
