1801 - Beech: crown lift to 5m

1804 - Field maple: clear building by 2m retaining overhanging branches outside this distance; crown lift to 5m over the carriageway and 3m over the remainder.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
