Thanks for your message.

1. The existing floor plans won't change with the doors as it's literally switching 3 windows to two sets of doors on the plans. Do you still require them? No internal structure will change bar the widening of these spaces.
2. We would be looking to purchase doors through Reddish Windows because they do sympathetic wooden doors for period properties. They have been recommended to us -what additional information would you require please?
3. We have no doors to be replaced. Just the two existing windows from the previous extension to become doors. The kitchen window which is in the fabric of the listed building part, previously was a door but was blocked up. The brickwork was not toothed out so it has a hard line of brickwork we could remove without much interference to the original brickwork.
