Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Beech - (T1) - Reduce the height by approximately 5 metres.

There is a weak fork at 5 metres and a large, decayed pruning wound at 8 metres. The tree was, until recently, part of a group of three but the other two trees, both Red Oaks, have recently been removed. One in high winds and one felled due to severe basal decay. The identified weaknesses are now exacerbated by the tree's exposure to weather events that it was previously sheltered from.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
