We have a tree in our garden, the only one I believe sitting in the rear garden from 13-16 Abbotsfield close. On the lower part of the tree, first 12 feet, there are branches that have grown here and now starting to cover the garden from 6ft to around 12ft. This is why we want to carry out the work. It would involve cutting up to 10 branches. I believe this is an acorn tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
