T1, Pine, seawards side had died back and lots of dead wood, landward side has become dominant where it has air space. Dead wood the complete tree for maintenance and prune the dominant limbs back by 3-4 to counter the effects of the wind and growth form removing pulling weight. 2, Hedge line to road side of Evergreen Oaks, dead wood in canopies, one snapped limb that has become snapped and twisted resting in the hedgeline. Remove the dead wood, remove the snapped twisted limb and raise up to meet a highways 154 notice.
