Both trees have had little or no maintenance for many years and are overgrown for their position. Bay - Very large, multi-stemmed clump. Reduce in height to approx. 2m, to improve manageability, whilst maintaining screen between adjoining gardens.
Cypress - Reduce height by approx. 3m and raise crown to 3.5m, improving form and light penetration.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
