- 9. new coordinated reflected ceiling plans
- 10. proposed works to the stone stairs, including temporary bracing and protection during works (inc method statements)
- 11. wall treatments, including new and restored decorative plasterwork (incl. method statements)
- 12. new fireplaces, incl. hearths, fire surrounds, fire backs with key junctions with existing fabric
- 13. tanking or any damp proofing works with key junctions with existing fabric

You must not start any work on these parts of the development until we have approved what you have sent us. You must then carry out the work according to these approved documents."
