Listed Building Consent for Alterations to Dwellinghouse to Include Installation of Woodburning Stove into Existing Fireplace and Chimney, Block Up Existing Doorway and Installation of Rear Doorway at 41 North Deeside Road, Kincardine O'Neil, Aberdeenshire, AB34 5AA

I refer to your application for the above. Under the Planning (Listed Buildings and Conservation Areas) (Scotland) Act 1997 there is a legal requirement for the public display of the attached notice for a period of not less than 7 days. The notice must have been on public display for a minimum of 7 days prior to the expiry date for public comment, 23 May 2024

The notice should be displayed in a prominent position at or near the site, e.g where it is an alteration to an existing building, on a gate or a storm water downpipe, or, if the development has yet to commence, a fence post, tree or similar. The Planning Officer dealing with your application will check the public display of the notice on a subsequent site visit to ensure compliance with the legislation requirement.
