After discussion with a local arborist, the following was recommended:

Beech Tree 1 - 20% weight reduction and crown thin, to allow continued maintenance and remove danger of falling branches.
Beech Tree 2 - 20% weight reduction and crown thin, to allow continued maintenance and remove danger of falling branches.
Beech Tree 3 - 20% weight reduction and crown thin, to allow continued maintenance and remove danger of falling branches.
