Originally the room was divided by a hardboard partition archway which was obviously a temporary addition. We requested the removal of this partition wall to leave the open kitchen diner - two photographs provided to show the present kitchen.

The original layout of the bathroom consisted of a small separate toilet and basin for which access to the actual toilet was limited in space. The bath and second basin had no separating wall to hallway and access through to the lounge was through this bathroom. We have reconfigured the bathroom layout to give separate access to the lounge and a separate bathroom with bath, shower, toilet, basin and large cupboard - two photographs provided to show new bathroom layout.

A door between the dining room and snug has been moved 90 cm to the middle of the wall.
