T1 - Lime tree, pollard back to approximately 1.0m beyond the most recent pollard points and crown the two lowest south facing branches to reduce the overhang into the neighbouring property. The reasons for these works are simply to reduce the size of the tree so that it is a little smaller and increase the duration between re-pollarding slightly too.
