H1 - Laurel - growing in the left-hand corner along the back boundary in the rear garden To reduce the width of the extended section growing from left to right, by 1m To clear obstruction to the shed by reducing the branches growing towards and over the shed roof To trim back off the neighbour's garden along the back boundary Please note, the height is to be retained
