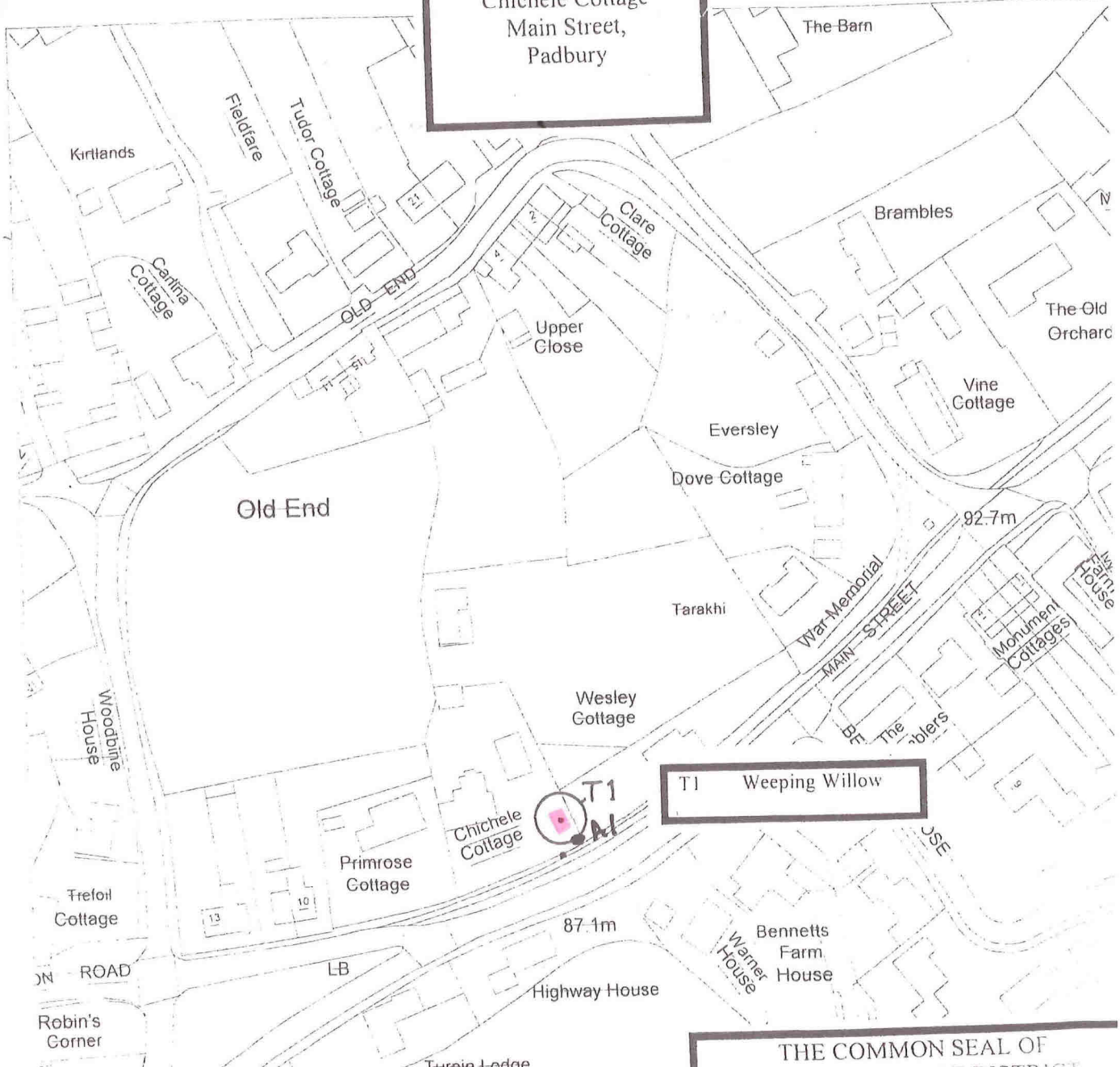
7. Additional Information

A similar ~~process~~ operation was carried out at Chichele Cottage in 2021 to counteract the shrinkage of the underlying Oxford clay caused by the high water demand of the nearby Weeping Willow subject to the Tlo
