A Eucalyptus tree was planted 25 years ago 3 yds. from the boundary fence alongside the road B1127. It is now 40ft high and needs pruning back to avoid large vehicles inc. double decker buses. A reduction in bulk is also needed to reduce its wind resistance in these days of more turbulent weather. This is to reduce the likelihood of being blown onto our house.  This tree is not native to this country and has only been part of the street scene for 20 years.  We have been advised by a tree surgeon Ben Rouse
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
