T2• Beech trees, located in property of 3 Christchurch Close: Shape back North Western aspect by up 2.5metres to leave canopy spread of 6 metres, pruning to suitable lateral growth points with pruning wounds <90mm, to give at least 2.5 metres clearance from structure of Ewshot House, to drip line of canopies. (TPO 70/00441/HDC). To minimise debris entering gutters and mitigate this nuisance.
