# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The Large oak tree directly outside the front of our house by our front garden.

The oak tree roots have penetrated through our damp course and are currently growing very rapidly in to our downstairs cloakroom area. Due to the actionable nuisance the tree roots have caused we now have a very large amount of repair works needing to be carried out.

Because of the damage caused so far, and the fact the roots are continually growing, we would like to have the oak tree completely removed so that we don't find ourselves in this horrendous situation again.

We have an arboriculturist report and tree root analysis confirming it is the oak tree that has caused the damp and damage to our property.

There is also a large cypress tree on our neighbours front garden, 7 Troutbeck Walk, where their tree roots are also a big part of the damage caused and have penetrated the damp course also.

Because of the actionable nuisance caused by their cypress tree we will be asking our neighbours to have their tree removed too.

The arboriculturist report and tree root analysis also confirms the cypress tree is to blame for damage caused.

We do not want to plant any other trees In place of the oak and cypress tree as we feel that there are lots of trees very near to our property already and we don't feel, after all we have battled with that we need any other trees planted that could potentially cause other damage.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
