T1 Silver Birch: Crown lift to approximately 10m by removing lower branches back to main stem. Reason: enhance the structure and strength of the tree, minimize the risk of tree/branches falling caused by frequent extreme weather and reduce severely blocking out light to the extraordinarily close property.
