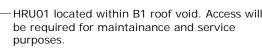


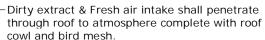

- stated otherwise. This drawing represents the design intent
- & strategy. It is neither an installation nor a co-ordination drawing. All ductwork, heat recovery units and fans
- shall be securely fixed to the building structure with the use of a proprietary bracketing system.
- Volume control dampers shall be provided to ductwork branches as indicated. All ductwork shall be galvanised mild steel and all legs shall be insulated in 25mm duct wrap.
- All ventilation systems shall be fully commissioned upon completion.
- 10. Access doors shall be installed adjacent to every fire damper and serviceable component
- 11. Fire stopping shall be provided where services penetrate through new and existing firewalls. The contractor shall refer to the fire strategy drawings and documents
- 12. The contractor shall co-ordinate with the building fabric/structure and other trades. 13. All ductwork shall be designed, manufactured in accordance with BESA (Building & Engineering Services Association.) Ductwork specification
- DW144. 14. Fire dampers and smoke dampers shall be installed in all fire wall to suit the level of fire compartmentation requirements in line with the fire strategy drawings and documents. Access panels shall be installed in accordance with the damper manufacturer requirements for access and
- maintenance. 15. All grilles and diffusers shall be installed c/w VCD's and plenum box.
- 16. All grilles and diffusers shall be independently supported where
- necessary.
- All MVHR units shall be installed with 17 adequate maintenance access. 18. All positions of ceiling mounted equipment shall be co-ordinated to suit
