Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- 1) Reduce height of laurel hedge (shown on diagram) between our garden and the Ipswich High School playing field - this hedge has grown very high and the top branches lean over the footpath, making it very dark. We have contacted Kevin Smith, Head of Estates at Ipswich High School who is happy for us to do the work. All the hedge is on our land, but leans over into the adjoining field.
- 2) Fell G1 on the diagram - 1 Western red cedar and 1 Lawson cypress, both graded C1 (low quality and value). They on the boundary between us the road to the marina. They have grown very tall and in fact the red cedar was damaged in a storm a few years ago and the the top has already fallen off. They are blocking light and space to other trees in the garden, notably a Scots pine and a Norway Maple (graded A1 and B1 respectively). We plan to replace them with a lower and more natural hedge that acts as a screen between us and the road.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
