Thank you for your recent request to make a Full Pension Encashment. The encashment was completed on 11/09/2015 and will be paid by the agreed method.

We have deducted income tax from the amount payable, and forwarded this to HM Revenue and Customs. Under current Revenue rules, you are entitled **to up to 25% of the value of your plan free of tax**. The remainder of the plan value will be taxed using the PAYE Emergency Tax Code.

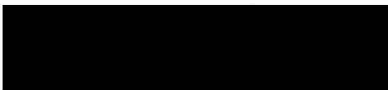
- The tax deducted may not be the right amount due, when all of your income for the year is taken into account. After next 5 April HM Revenue & Customs (HMRC) will check whether you have paid the correct amount of tax, and if not they will contact you.
- If you think you have paid too much tax you can ask HMRC for a tax refund now - you do not have to wait until 5 April. To claim a refund call your usual HMRC office. You can find the numbers on the 'contact us' pages of the HMRC Website at www.hmrc.gov.uk.

Please be advised that following this encashment your tax position has changed. A reduced annual allowance will be in place for contributions to money purchase pension arrangements. Contributions in excess of this allowance will be subject to a tax charge and could also further impact your annual allowance.

By making this encashment you are using up 1.48% of your standard Lifetime Allowance. We have enclosed your P45 form for your information.
