Description of Proposed Works

Replacement of conservatory with two storey extension.

This is a proposal to demolish a glazed single storey conservatory and replace it with a two-storey brick extension on the south-east side of the property. The proposed extension will not extend further from the house than the existing conservatory.

The first floor exterior will be rendered to match the first floor exterior of the original house. The ground floor exterior will be a combination of brick, render and/or wood cladding, in order to match the ground floor exterior of the existing house, extension and annex.

The ground floor extension will comprise an open plan bar and lounge area, guest bedroom and en-suite bathroom. An existing snug will be connected with sliding doors. The first floor extension will comprise two study areas and two en-suite shower rooms which will be accessed through existing first floor bedrooms.
