Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

A single Strawberry Tree arbutus unedo, I wish the tree to be felled.

Danger. The tree is dangerous. Its canopy is top heavy and this causes the tree to sway alarmingly in high winds. It is now of such a height that it reaches your roof and that of your neighbours property. If it were to fall it could cause massive, probably uninsured damage to two house, and it could obviously kill anyone it fell on or who was within a house it fell on. Even a branch falling could seriously injure anyone it struck.

Damage. The tree roots are damaging your front walls and those between your property and David's. It is causing heave to your courtyard making it uneven and dangerous to walk on. The roots are also starting to affect the drains and incoming electricity cables and the telecoms wires that serve many of the houses in the street. You are concerned that it has already started to undermine your house.

Right to light. It is obstructing all natural light into your house, obscuring all the windows on all three levels of your home making it dark and depressing. This affects your mental health.

Nuisance. The tree creates significant nuisance to you, David and your neighbours. For six months of the year it produces masses of bright red fruit and white berries. These have to be swept daily for half the year as they would otherwise stain anyone's shoes and carpets. This has seriously affected your relationship with your neighbours leaving you anxious and unhappy. The foliage blocks the drains in the street causing flooding in heavy rain, and are now blocking the gutters of my house and both my neighbours houses.

I do not propose to replant a tree of these dimensions as it dwarfs my garden, however I would consider planting a smaller more appropriate tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
