T1 Sycamore of the MWA Arboricultural Report
Works: Crown reduce by 2.0m (linear reduction) all round and prune on a triennial cycle to maintain broadly at reduced dimensions.
Reason: Clay shrinkage subsidence damage at neighbouring property 83 Yew Tree Cottages, HX2 6UG. Please also see the Statement of Reasons for Works document submitted with this application.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
