Rear Garden:

T1 & T2: Mature Magnolia's: Approximately 8.00m: Thin crown density by 20%. Reduce by approximately 1.50m back to previous reduction points. Remove dead wood. General maintenance.

T4: Mature Holly: Approximately 5.00m: Mature Holly: Approximately 5.00m: Reduce by approximately 1.25m back to previous reduction points. General maintenance.

Front Garden:

T5: Mature Beech: Approximately 5.00m: (Over driveway): Reduce crown back from pollarded Plane trees by approximately 1.20m to clear. Reduce crown by 1.20m, approximately 20%. General maintenance/control encroachment.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
