LANDI CONIFER (CUPRESSUS) & SILVER BIRCH (BETULA PENDULA). THE TREES HAVE GROWN TO SUCH AN EXTENT THAT THEY ARE INTERFERING WITH SEVERAL TELEPHONE CABLES WHICH RUN ALONG THE UPPER SECTION OF BOTH TREES. IT IS ALSO THAT THE TREE LIMBS WILL CAUSE DAMAGE TO THE CABLES AT SOME POINT.

IT IS REQUESTED THAT PERMISSION BE GRANTED TO CLIMB ALL OFFENDING TREE LIMBS AND TO REMOVE THE HEIGHT OF BOTH TREES TO 3 FEET BELOW THE HEIGHT OF THE TELEPHONE CABLES. THIS WILL ENSURE THAT NO CABLE DAMAGE WILL OCCUR. ALL CUTS WILL BE IN ABUNDANCE WITH BS 3998, AND THE SITE WILL BE LEFT CLEAN AND SAFE.
