Archaeology requirements in regard to planning submission at Nile Street, Sunderland, SR1

As set out in the Sunderland Planning Validations 2024, an Archaeology Assessment is typically required for all Full Planning Applications. Appended to this letter is correspondence with Rachel Grahame, Tyne and Wear Archaeology Officer.

Within Rachel Grahame's email, she advises that they are not looking for any further archaeological work prior to the determination of any planning applications due to previous investigations, and that a desk-based assessment is unlikely to add further knowledge of the site.

In summary, we have been advised that there is currently sufficient information regarding the site to assess the site as having very low archaeological potential, and therefore a desk-based assessment is not required for planning submission.

Hi Dan,

I'm just picking up on Sophie's Sunderland caseload. She appears to have started preparing a specification for an archaeological desk-based assessment for this site, but having looked further into our records I don't think a desk based assessment is required.

Regarding any concern about burials, there seems to have already been considerable work done on the Bethel Chapel site in 2007, consisting of four reports for an assessment, building recording and evaluation. I only have index entries in the HER for these, with no reports (which is very unusual), and they are marked 'NOT IN PUBLIC DOMAIN'. This work was preceded by a ground penetrating radar survey in 2006, which I do have a report for, and followed by an excavation in 2010. If anyone can find the missing 2007 reports so that they could be added to the HER I would be very grateful.

I have a post-excavation assessment report from 2018 (attached) relating to the excavation in 2010, and it is apparent that the crypt was fully excavated, and four trial trenches were also excavated in the former chapel gardens (see section 8.1). These found no evidence of burials, and a watching brief was subsequently carried out on the demolition of the crypt (section 8.2). Having reviewed this report, I think as much as possible has been done to clear the site of burials, and taking into account Sophie's comments, I don't think the site has any remaining archaeological potential, given that it was developed for housing in the 19th century, redeveloped in the 20th century and then cleared c.2019.

If there is any remaining concern about human remains on the site, an archaeological watching brief condition on any planning consent for the site might be appropriate in case any disarticulated human remains are found during construction.
