I will attach a basic sketch of where the trees are located and the type of tree they are. I have spoken to numerous tree surgeons about the work that needs completing on the trees, but have no official reports.

Identification of Tree(s) and Description of Works

Within the property, there are 7 sycamore trees, 1 ash tree, and 1 birch tree. (T1 is ash) (T2, T3, T4, T5, T6, T7, T8, T9 are sycamore) (T8 is birch). The trees are just in need of a slight thinning of the crown and removal of new lower branches. T2 and T3 are causing significant light issues in neighbouring gardens and T4 - T19 are causing significant light issues in our garden. We have spoken to numerous tree surgeons who think that a slight trimming to the crown could benefit the garden and the health of the trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
