121 Main Street, Skidby has a 3.36 acre paddock SW of the house. In the North corner of the paddock, closest to the house, is a block of stables and feed room / tack room. This was approved and built in 2013, planning ref. 12/04018/PLF

The proposed storage container site is behind this existing stable block on its West side, because here it will be hidden from view by the gradient of the land, by the existing building, and by many mature trees and hedges.

Behind approved stable block and 1 metre from its West side, add storage containers for personal use ancillary to keeping horses for private use of residents of 121 Main St, Skidby.

We have chosen a location that is almost completely hidden from the view of neighbours, by mature trees, hedges, by the sloping land and by the existing stable block. Any small parts that could still be seen we plan to screen with new hedging. The storage units will be steel shipping containers, painted dark green to blend with the trees and the existing dark green stables, and maintained in a neat and tidy condition.

Existing stable block: horizontal shiplap boarding painted dark green, on single brick plinth, on concrete slab base. Existing stable block roof, of apex 3m high, is dark grey fibre cement roof sheets with 3 clear panels for light, and uPVC black guttering at 2.44m high.

Proposed materials and finishes:

Proposed storage containers behind the existing stable block: Steel shipping containers painted dark green and maintained to look neat and tidy and to blend in with boundary lines' trees and hedges. New hedging to be planted along the sides of the units and extending across the back of the existing stable block. Unit 1 = 6m x 4.89m x 2.59m high. Unit 2 = 6m x 2.44m x 2.59m high. Sitting on corner pillars of grey paving slabs 600mm x 600mm x 50mm deep. Uphill edge to be sunk approximately 1 metre downwards, similar to adjacent existing stable block, to reduce visibility. By extending, by 5 metres in a SW direction, the existing grassed sloping earth bank that was created when the stables were built. Location chosen to be barely visible to neighbours due to mature trees, hedging, existing stable block and slope of ground.
