- T1 Hornbeam Remove 1 lowest branch, which is shading laurel hedge
- T2 Hornbeam Crown raise up to a height of around 8m, by means of removing 3 branches, to open up garden and allow light to reach lawn and boundary hedge
- T3 Hornbeam Crown raise up to a height of around 10m, by means of removing 5 lower branches from stem, to open up garden and allow light to reach lawn.
- T4 Sweet Chestnut Re-pollard, removing regrowth since previous pollard, to prevent regrowth from failing.
- T5 Sweet Chestnut Removal of epicormic growth from stem, to a height of around 10m, to create clearance from out building.
- T6 Hornbeam Crown raise up to a height of around 8m, by means of removing branches below crown break to reduce suppression of shrubs.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
