T1 Pine: reduce eastern and southern aspects of the tree by 1.5-2m (current radial spread 7m on both eastern and southern aspects) and remove deadwood

T2 Spruce: poor specimen, reduce to a 2m stump/ground level in order to benefit neighbouring trees as part of thinning

T3 Pine: dead, fell to ground level

  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
