Mature Scots pine on roadside boundary. This tree is now over mature and is within the fall radius of 2 properties and Highway. It is also now leaning towards one of properties. There is a basal cavity at the base. Recommendation is to fell to ground level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
