T1 Ash. Removal of T1 on safety grounds. T1 is showing considerable signs of Ash Dieback, and the tree owner has noted significant levels of decline over the last three years, with only minimal live growth last season.

T1 lies within striking distance of the property and is directly over a parking area and frequently used part of the garden.

There is also a signifacant bark inclusion at the base of the tree which divides the town stems and creates a potential weak point.

Due to the deteriorating condition and location of T1 is is believed that removal is required.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
