Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1-Bay Laurel: Reduce down in height by around 25% in order to manage the size of what has been left unmanaged and beggining to out grow its location.

T2-Beech: The tree is located on an elevated position high on a raised slope. The tree has an acutely tight fork junction at circa 4m from ground level which due to the increased weakness as a result has an elevated risk of failure if left unmanaged. Undertake an upper crown reduction of no more than 1.5m ensuring that no pruning wounds exceed 50mm in diameter, and a lateral branch reduction of no more than 1.25m ensuring that no pruning wounds exceed 40mm in diameter.

T3-Plum: The tree has extensive dieback throughout the crown and is a poor specimen tree with limited longevity. Fell as close to ground level as practically possible.

T4-Holly: The tree has historically been poorly prunes leaving it a poor specimen with limited longevity within its current environment. Fell to ground level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
