Higher in the tree there are rubbing and crossing tertiary branches which also reduce the tree's structural integrity. As the tree is leaning over a public footpath situated near a school and used by school children, their parents and the general public the tree needs to be removed in the interest of public safety.

The property is surrounded by established trees and it's not possible to plant a replacement tree in the garden of 53 Lilliput Road due to the size of the garden and it not being detrimental to the property.
