G1- Lime - Re-pollard the previously pollarded trees and select to remove 3-4 of the weaker stems to benefit the better adjacent trees.

T1 - Lime - Pollard to match the other pollarded trees - or thin by 30% by removing selected lower limbs extending out over the adjacent garage.

G2 - Lime -Pollard to match the other pollarded trees - or thin out the row by removing 3-4 of the weaker stems to benefit the better adjacent trees and form better individual trees.

Reason is to reduce the dominance, reduce tree litter and increase light to the garden.
