T1 Silver Birch - Remove – Specification to include complete removal by sectional dismantling to ground level. Treat stump with EcoMax Growth Inhibitor to prevent regeneration.

T3 English Oak - (Quercus Robur) Crown Reduction Works – Specification to include a height and spread reduction of 2.5m, cutting back to strong secondary growth. Shape and balance. New shape indicated in red on image. Belonging to Mr Mortimer Moore, who has given permission for the work to be carried out.

T5 Bay Tree - Remove – Specification to include complete removal by sectional dismantling to ground level. Growing over wall and into Mr Mortimer Moore's property.
