- T1. Oak Crown reduce by 2m. Current height 14m leaving at 12m. Prune to offer a 2m from building.
- T2. Hornbeam -Crown reduce by 2m. Current height 14m leaving at 12m. Prune to offer a 2m from building.
- T3. Ash Pollard leaving at 8m from ground level.
- T4. Hornbeam Clear cable offering a clearance of upto 2.5m

G5. Hornbeam - Crown reduce by 2m. Current height 14m leaving at 12m reduce radial spread over road by 2.5m to ensure suitable clearance from power cable. Current radial spread 8m leaving at 5.5m.

T6. Ash - Remove large low limb growing towards cable. Crown reduce by 2m. Current height 18m leaving at 16m.

- T7. Maple Clear cable offering a clearance of upto 2.5m.
- T8. Holly Crown lift over footpath to 3m from ground level.
- G9. Hornbeam Crown reduce group of trees by 2m. Current height 16m leaving at 14m.
- T10. Field Maple Coppice
- T11. Ash Coppice
- T12. Ash Coppice
- T13. Sycamore Remove low branch over footpath back to source.
- T14. Ash Coppice
- T15. Ash Pollard 0.5m below split
- T16. Oak Fell (dead tree)

T17. Oak - Heavily reduce due to large cavities and defects. Reduce in height by 4m. Current height 14m leaving at 10m.

T18. Hornbeam - Crown lift to 5m. Crown reduce by 2m. Current height 14m leaving at 12m.

The new owners are looking to manage the trees and reduce large canopies over the road and towards cables and buildings. The trees roadside have been left unmanaged for many years. The trees to coppice all have large decay present at the base and in the interests of safety given the proximity to footpaths, road, gardens and buildings, re-coppicing would be the best decision. T15 has recently snapped out and is hanging up within another tree. Some of the tree work is simple management to keep away from buildings and manage canopy size whilst some are preventive measure for safety.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
