T1 Lime: reduce height by 4m and shape sides/lateral limbs by 3m to suitable growth points to maintain shape.  large cedar used to shelter tree from wind, cedar has now been removed leaving lime exposed and client would like the tree reduced in height to match the adjacent limes along the row, approximately 3/4m lower than current tree.
