T1 Sycamore Tree.

We would like to reduce this trees crown spread garden side only by 3M, reduce the height by 3M and thin crown by 10%. The reason being is due to the excessive shading in the garden caused by this Sycamore Tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
